In February 2001, Sue Weaver contracted with a major department store to have the air ducts in her home cleaned. Unbeknownst to her, both of the men sent on the service call had criminal records. One of the men was a twice-convicted sex offender on parole. On, August 27, 2001, he returned to rape and murder her in her suburban Orlando home.

Sue's murder is not an isolated case. Tragically, many consumers are assaulted and murdered each year by people whose jobs allow them access to their victims. The Sue Weaver C.A.U.S.E., Consumer Awareness of Unsafe Service Employment, has been founded in Sue's memory to promote personal safety legislation and awareness. C.A.U.S.E. leads a national campaign to educate employers and consumers to the necessity of criminal background checks and to promote C.A.U.S.E. Certification of in-home service providers.

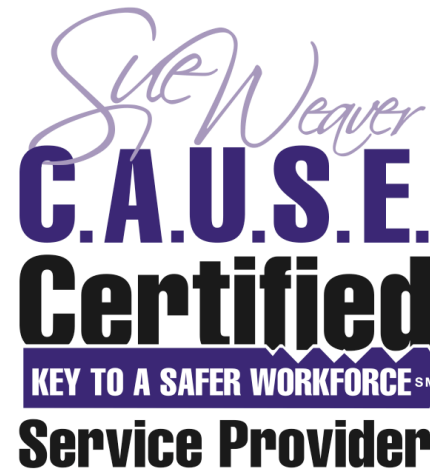
